### **General Notes:**

2. Tables A to C concern the public Acts of Nunavut. They include all Acts made to December 31, 2017 by the Legislature for Nunavut and any amendments to those Acts, except current appropriation Acts. They also include the laws of the Northwest Territories as duplicated by section 29 of the *Nunavut Act* (Canada) and laws made by the Legislature for the Northwest Territories pursuant to section 76.05 of the *Nunavut Act* (Canada).
3. References to statutes made before April 1, 1999 are references to the statutes made by the Legislature of the Northwest Territories. References to statutes made on or after April 1, 1999 are references to the statutes made by the Legislature of Nunavut.
4. The authoritative text of statutes made before April 1, 1999 can be ascertained from the *Revised Statutes of the Northwest Territories, 1988* and the Annual Volumes of the Statutes of the Northwest Territories. The Tables accompanying those volumes may be consulted for assistance.

Table B consists of two parts:

- **Part 1** - Public Acts repealed on or before December 31, 2017;
- **Part 2** - Public Acts that are spent as of April 1, 2017: “spent” Acts are primarily budget-related appropriation Acts, in force with respect to a particular fiscal year, so this table is made on an April 1 to March 31 fiscal year basis.
