Chapter 15

AN ACT TO AMEND THE LEGISLATIVE ASSEMBLY AND EXECUTIVE COUNCIL ACT

(Assented to May 16, 2002)

The Commissioner of Nunavut, by and with the advice and consent of the Legislative Assembly, enacts as follows:

- 1. The Legislative Assembly and Executive Council Act is amended by this Act.
- 2. The following heading and section are added after section 70:

TRANSITIONAL

70.1. During the period beginning on March 6, 2002, and ending on March 31, 2002, Schedule C shall be read as follows:

SCHEDULE C

INDEMNITIES AND ALLOWANCES

Indemnity for members

1. (1) For each member other than the Premier, a Minister or the Speaker, an indemnity of \$60,108.00 is payable during each fiscal year according to the terms and conditions set out in section 25 of the Act.

Indemnity for Premier, Minister and Speaker

(2) An indemnity of \$46,610.00 is payable to the Premier, a Minister and the Speaker during each fiscal year according to the terms and conditions set out in section 25.

Committee meeting indemnity

3. A committee meeting indemnity is payable according to section 27 to each member of a committee of the Legislative Assembly for each day served at the rate of \$207.00 per day.

Additional indemnity of Deputy Speaker, chairpersons and deputy chairpersons

- 4. (1) In addition to any other amounts payable under this Schedule, an indemnity shall be paid
 - (a) to the Deputy Speaker at the rate of \$72.00 for each day that the Deputy Speaker performs the duties of chairperson of the Committee of the Whole or Speaker during a session;
 - (b) to a deputy chairperson of the Committee of the Whole at the rate of \$72.00 for each day that the deputy chairperson performs the duties of chairperson of the Committee of the Whole during a session; and
 - (c) to the chairperson, deputy chairperson or acting chairperson of a Standing Committee of the Legislative Assembly at the rate of \$72.00 for each day that the chairperson, deputy chairperson or acting chairperson performs the duties of chairperson during a meeting of that Standing Committee.

Maximum indemnity

- (2) Where a person performs in one day two or more of the duties referred to in subsection (1), that person shall only be paid as if he or she had performed one duty.
- **3.** Paragraph 40(1)(a) is amended by the addition of "and sections 28 and 31" after "B and C".
- **4. Section 71 is amended by striking out** "striking out" **and substituting** "repealing".
- 5. Section 75 is repealed and the following substituted:
- 75. (1) Subject to subsection (2), the *Legislative Assembly and Executive Council Act*, R.S.N.W.T. 1988, c.L-5, as duplicated for Nunavut, is repealed on April 1, 2002.
- (2) Section 6.1 and sections 23 to 28 are deemed to have been repealed on March 6, 2002.
- 6. Section 76 is repealed and the following substituted:
- 76. (1) Subject to subsection (2), this Act comes into force on April 1, 2002.
- (2) Section 11, subsections 25(1), (2) and (4), and sections 26, 27 and 70.1 are deemed to have come into force on March 6, 2002.
