OCCUPATIONAL TRAINING AGREEMENTS ACT

Program established

1. The Minister may establish, organize and promote programs to develop and improve the occupational and other skills of persons. S.Nu. 2011,c.10,s.24.

Agreements

- **2.** (1) The Minister may enter into agreements on behalf of the Government of Nunavut with
 - (a) the Government of Canada,
 - (b) the government of a province, or
- (c) any municipality, agency, organization, corporation or person, for the purpose of arranging for or providing for programs, research or services relating to
 - (d) occupational or other skills, or
 - (e) the improvement of the labour force.

Minister empowered to act

3. (1) The Minister may do every act and exercise every power for the purpose of implementing every obligation assumed by the Government of Nunavut pursuant to an agreement entered into pursuant to section 2.

Idem

- (2) Without limiting the generality of subsection (1), the Minister may
 - (a) provide courses of occupational training in Nunavut to adults;
 - (b) provide courses in Nunavut for apprentices who are adults;
 - (c) give or undertake to give a course to, or arrange or undertake to arrange a course for, adults and to provide services in connection with such a course;
 - (d) be remunerated by the Government of Canada for any courses given, developed, undertaken or provided;
 - (e) purchase, erect or convert buildings, machinery, equipment or other facilities for use in occupational training including such facilities as may be required for training adults, including adults with special training needs;
 - (f) provide for the initial operation of the facilities in paragraph (e); and
 - (g) provide for the development of courses, to be given in such facilities.
