

Chapter 21

AN ACT RESPECTING CONSTITUENCY NAMES AND SUPERANNUATION OF CERTAIN INDEPENDENT OFFICERS OF THE LEGISLATIVE ASSEMBLY *(Assented to November 5, 2012)*

The Commissioner of Nunavut, by and with the advice and consent of the Legislative Assembly, enacts as follows:

Nunavut Elections Act

1. (1) The *Nunavut Elections Act* is amended by this section.

(2) Subsection 31(2) is amended by striking out “.” and the substituting “, as revised in accordance with subsection (2.1).”.

(3) The following is added after subsection 31(2):

Amendments to constituency names

(2.1) Where the constituency names appearing in Part I of the Schedule are amended, the Chief Electoral Officer shall, without delay, revise the DVD referred to in subsection (2) to reflect the new constituency names.

(4) The following is added after subsection 188(4):

Superannuation

(4.1) Despite subsection (4), the Chief Electoral Officer is deemed to be a member of the public service for the purposes of superannuation.

(5) Subsection 272(1) is amended by striking out “commencement” and substituting “enactment”.

(6) The schedule set out in the Act is repealed and the schedule set out in the schedule to this Act is substituted.

Official Languages Act

2. (1) The *Official Languages Act*, R.S.N.W.T. 1988, c. O-1, as duplicated for Nunavut by section 29 of the *Nunavut Act (Canada)*, is amended by this section.

(2) The following is added after subsection 19(3):

Superannuation

(4) The Languages Commissioner is deemed to be a member of the public service for the purposes of superannuation.

Official Languages Act (2008)

3. (1) The *Official Language Act*, S.Nu. 2008, c.10, is amended by this section.

(2) The following is added after subsection 16(3):

Superannuation

(3.1) Despite subsection (3), the Languages Commissioner is deemed to be a member of the public service for the purposes of superannuation.

(3) Subsection 46(3) is repealed.

Coming Into Force

4. (1) Subsections 1(1) and (5), and sections 2 and 3 come into force on assent.

(2) Despite subsection 272(1) of the *Nunavut Elections Act*, subsections 1(2), (3) and (6) come into force immediately following the coming into force of *An Act Respecting the Constituencies of Nunavut*, S.Nu. 2011, c.24.

(3) Subsection 1(4) comes into force on a day to be fixed by order of the Commissioner, on the recommendation of the Management and Services Board.

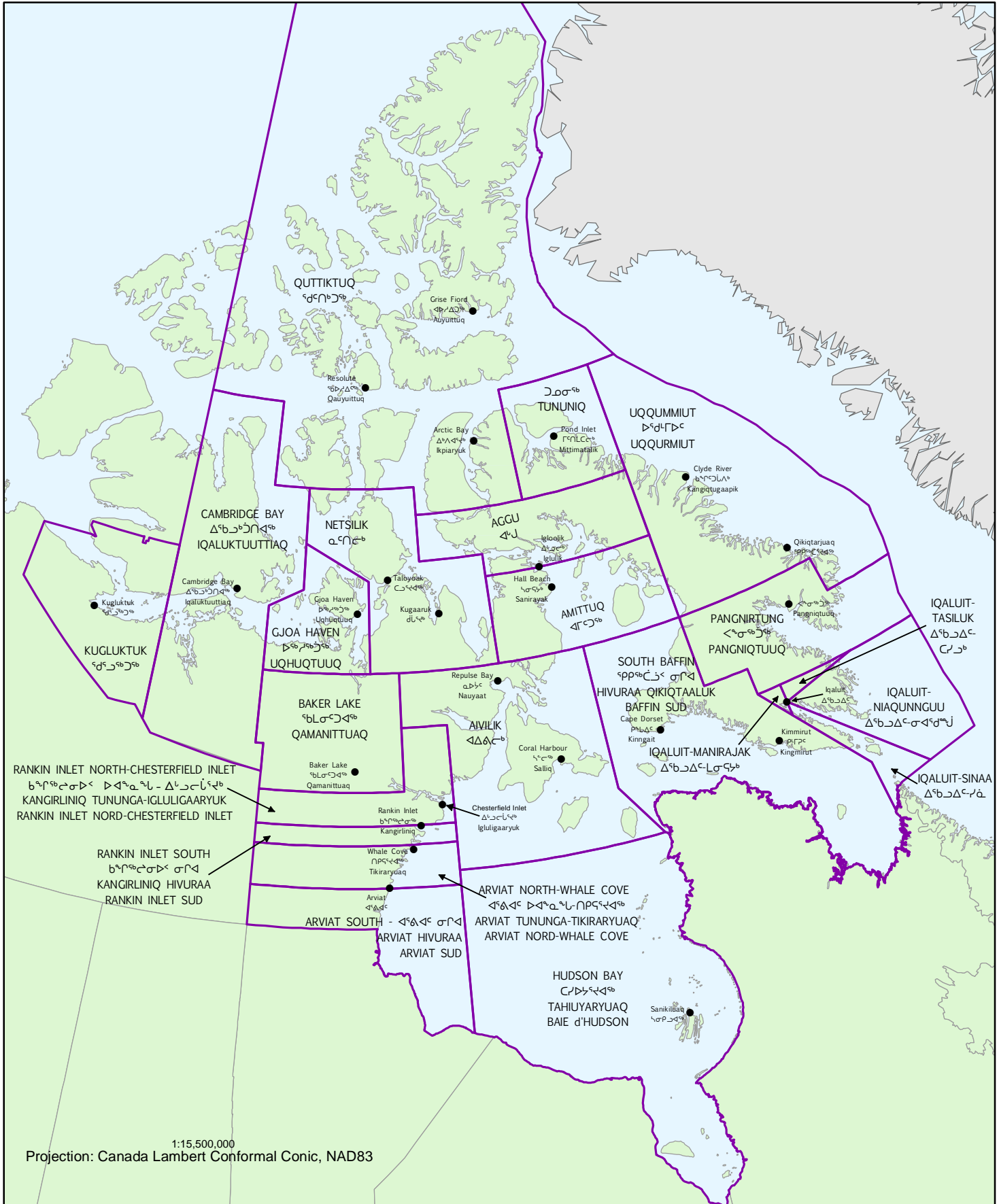

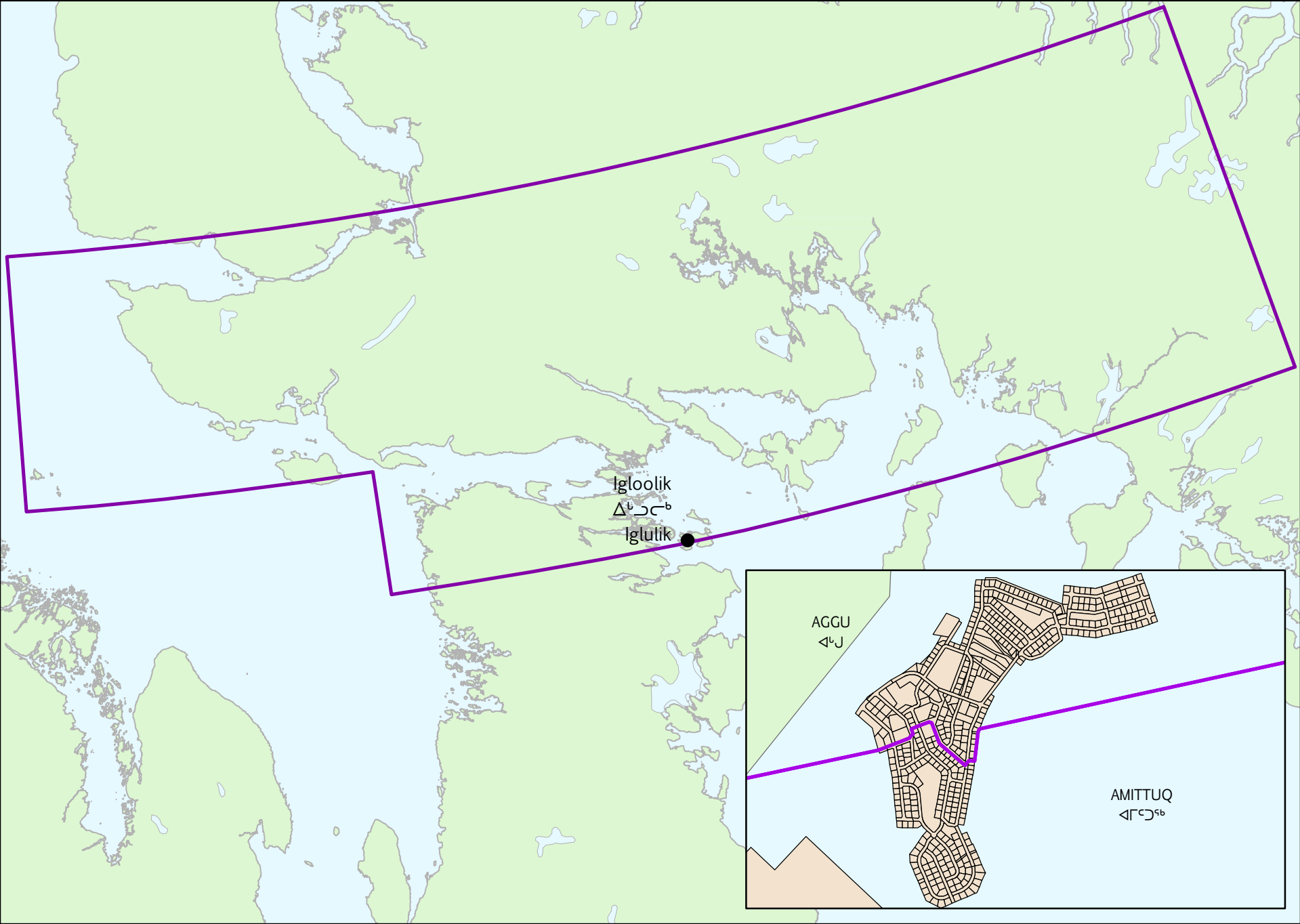

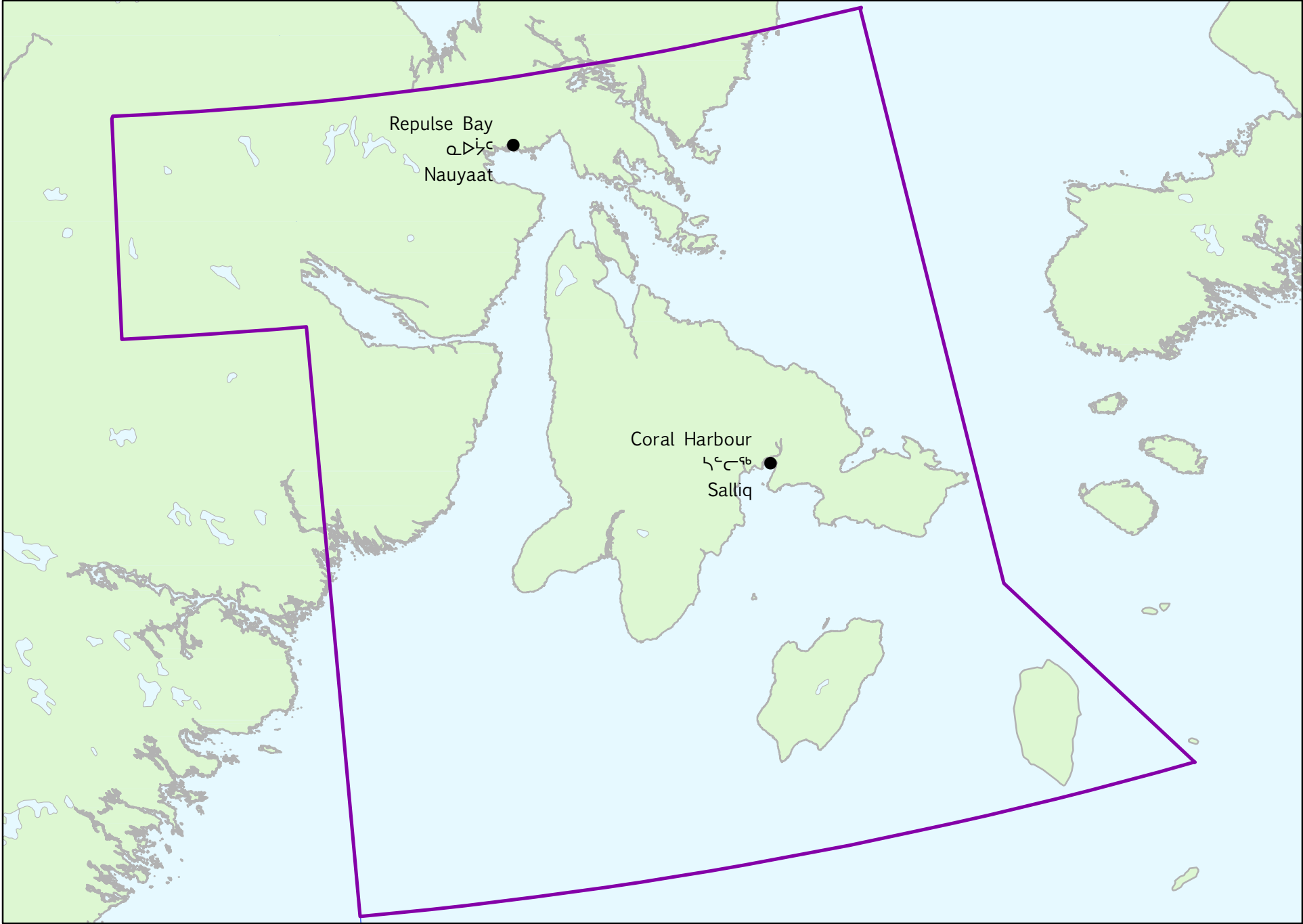

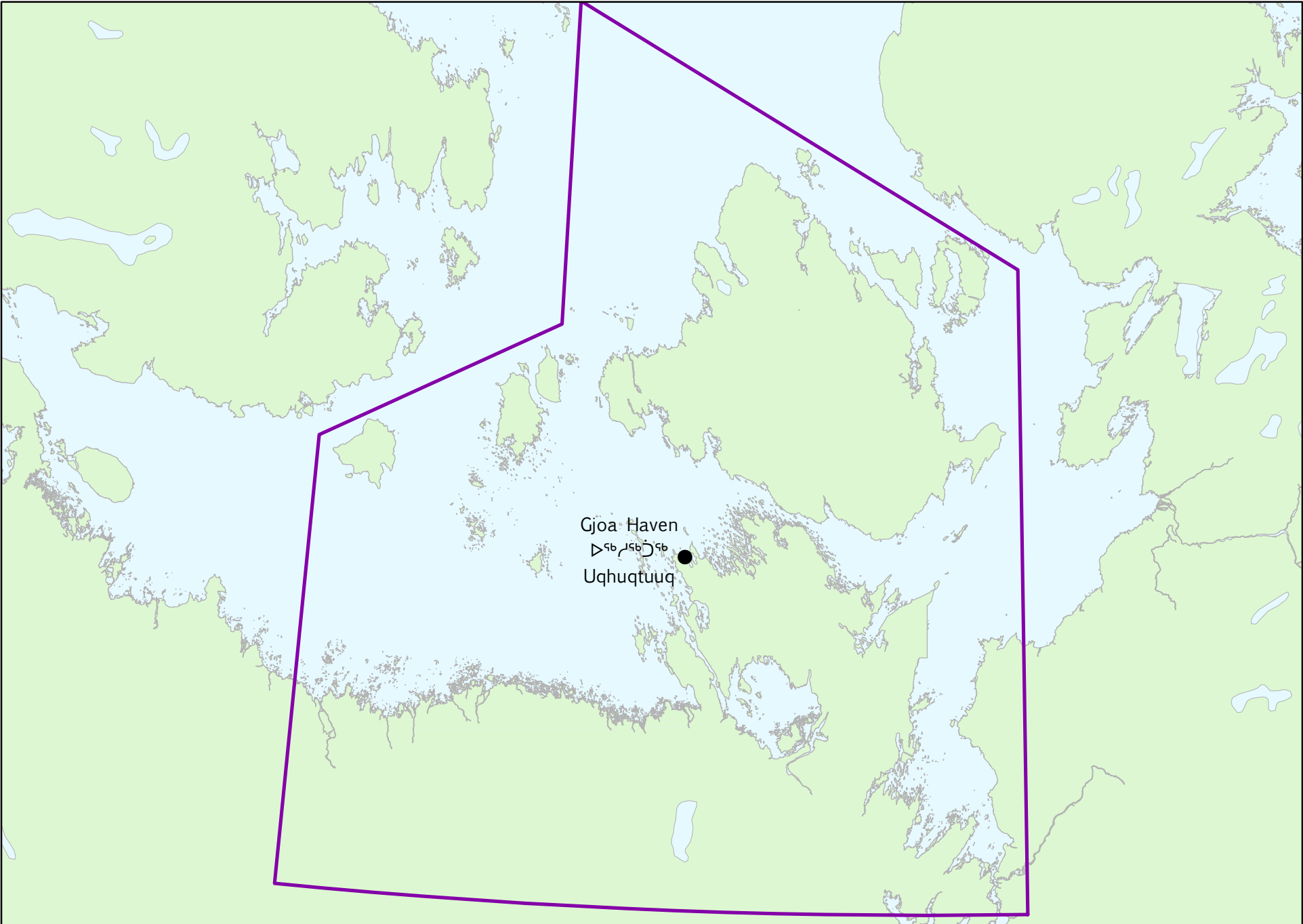

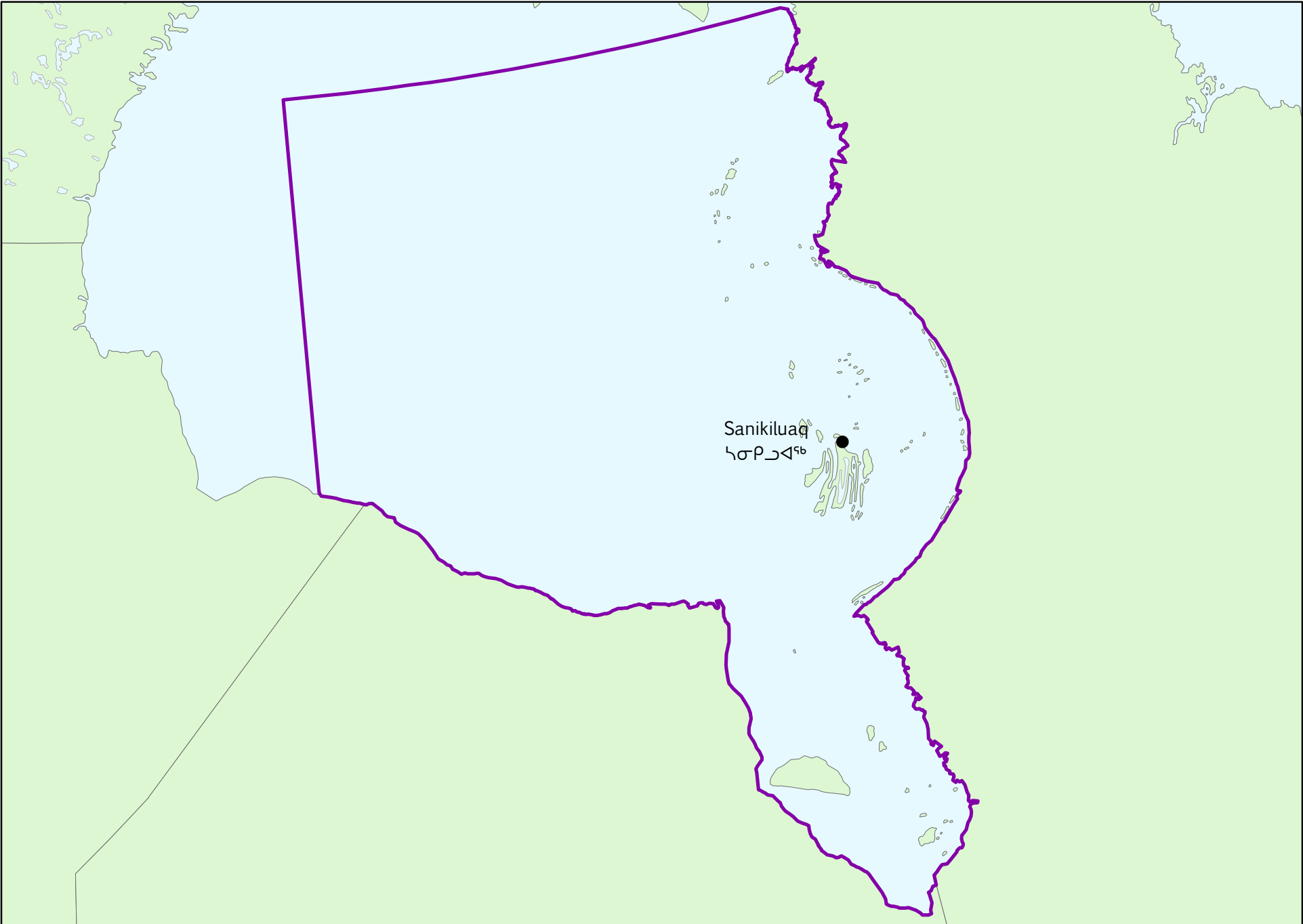

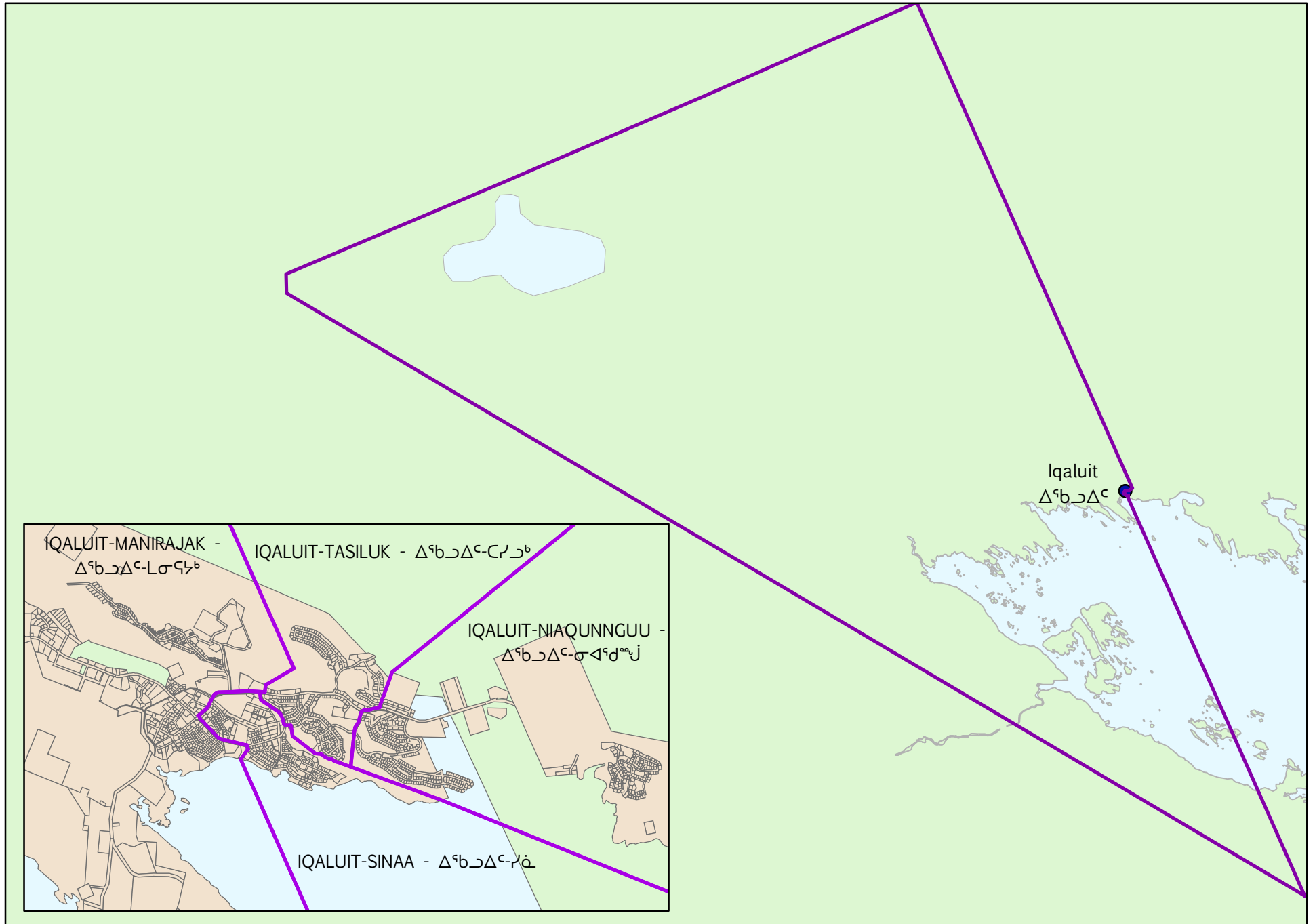

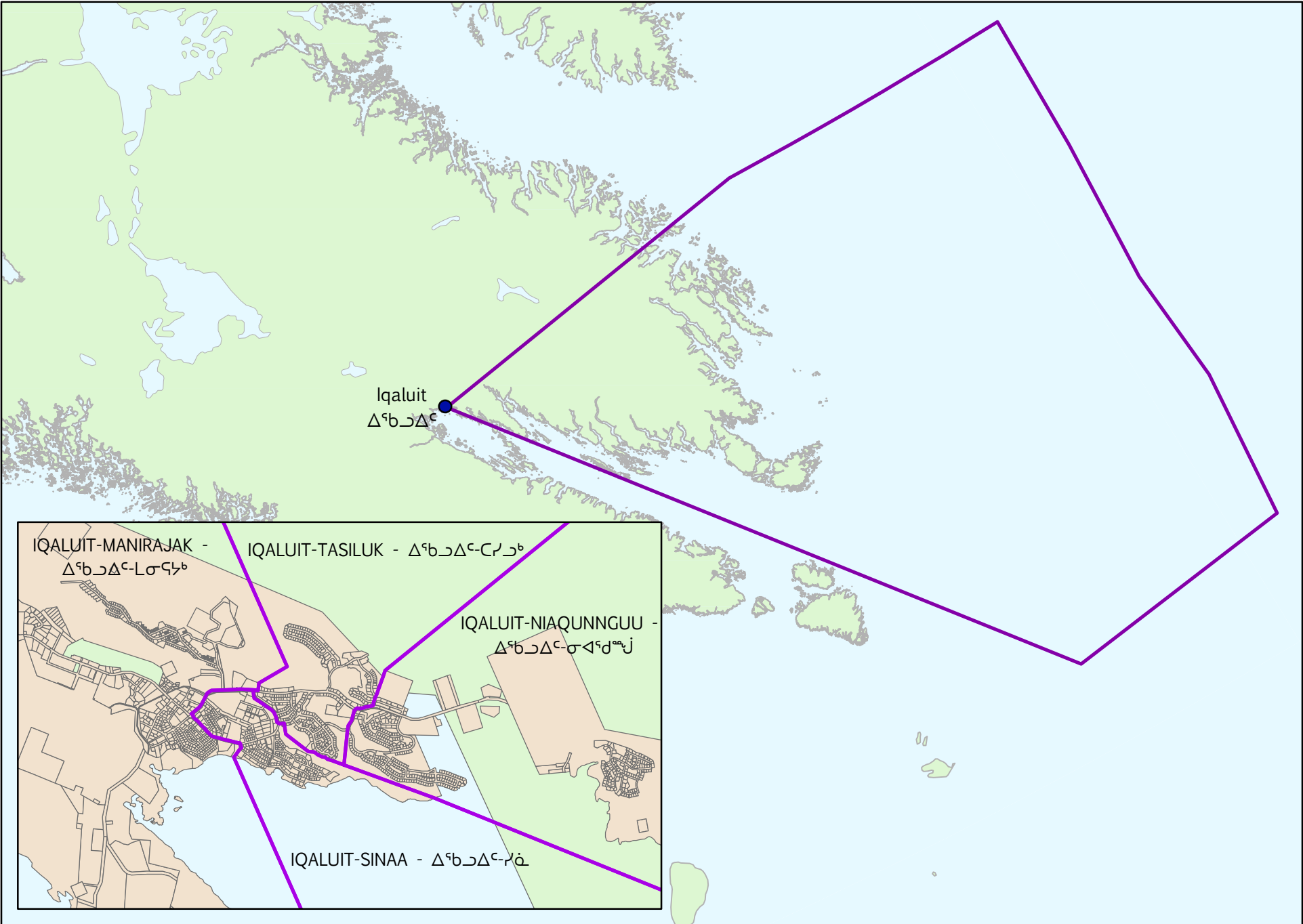

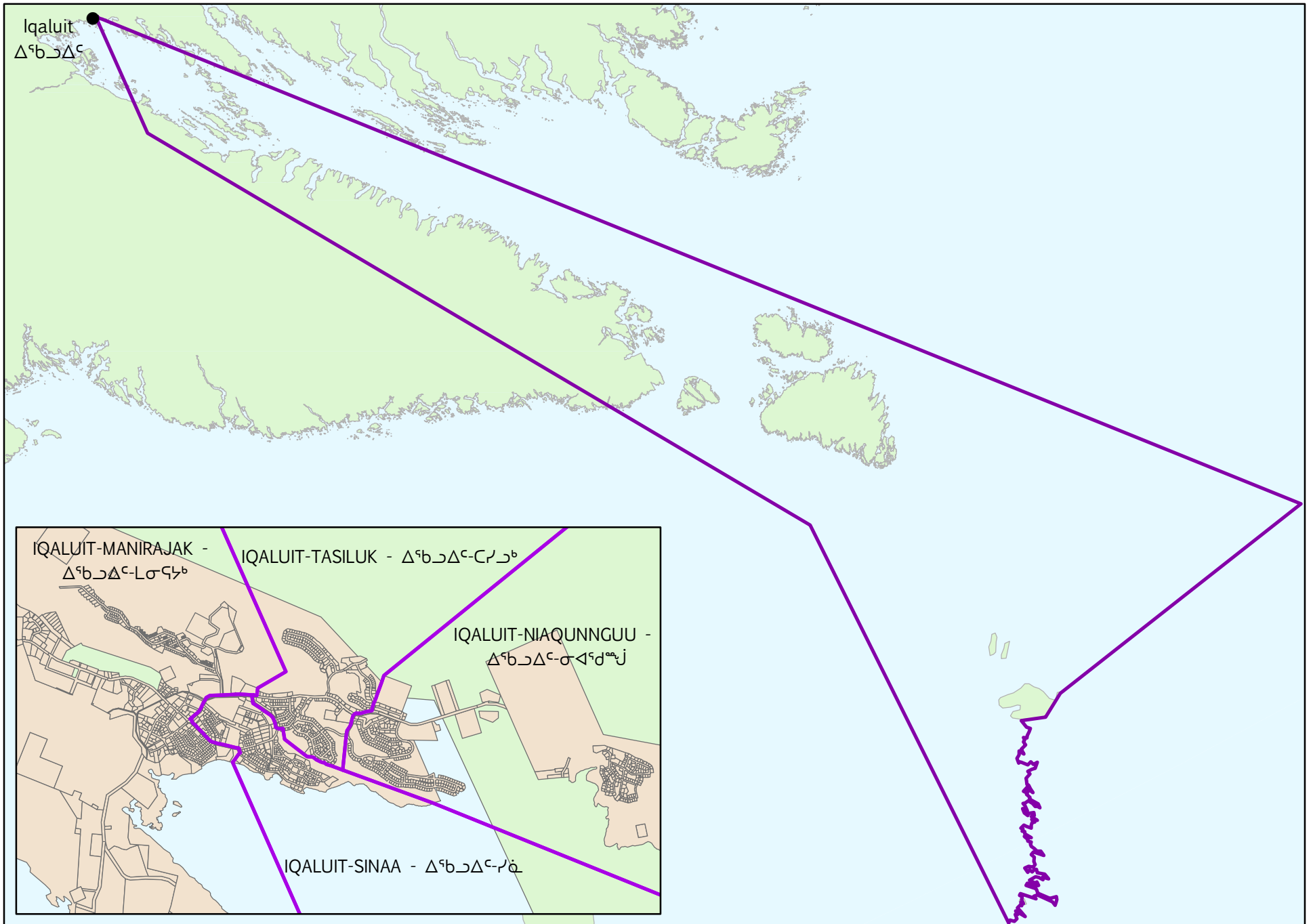

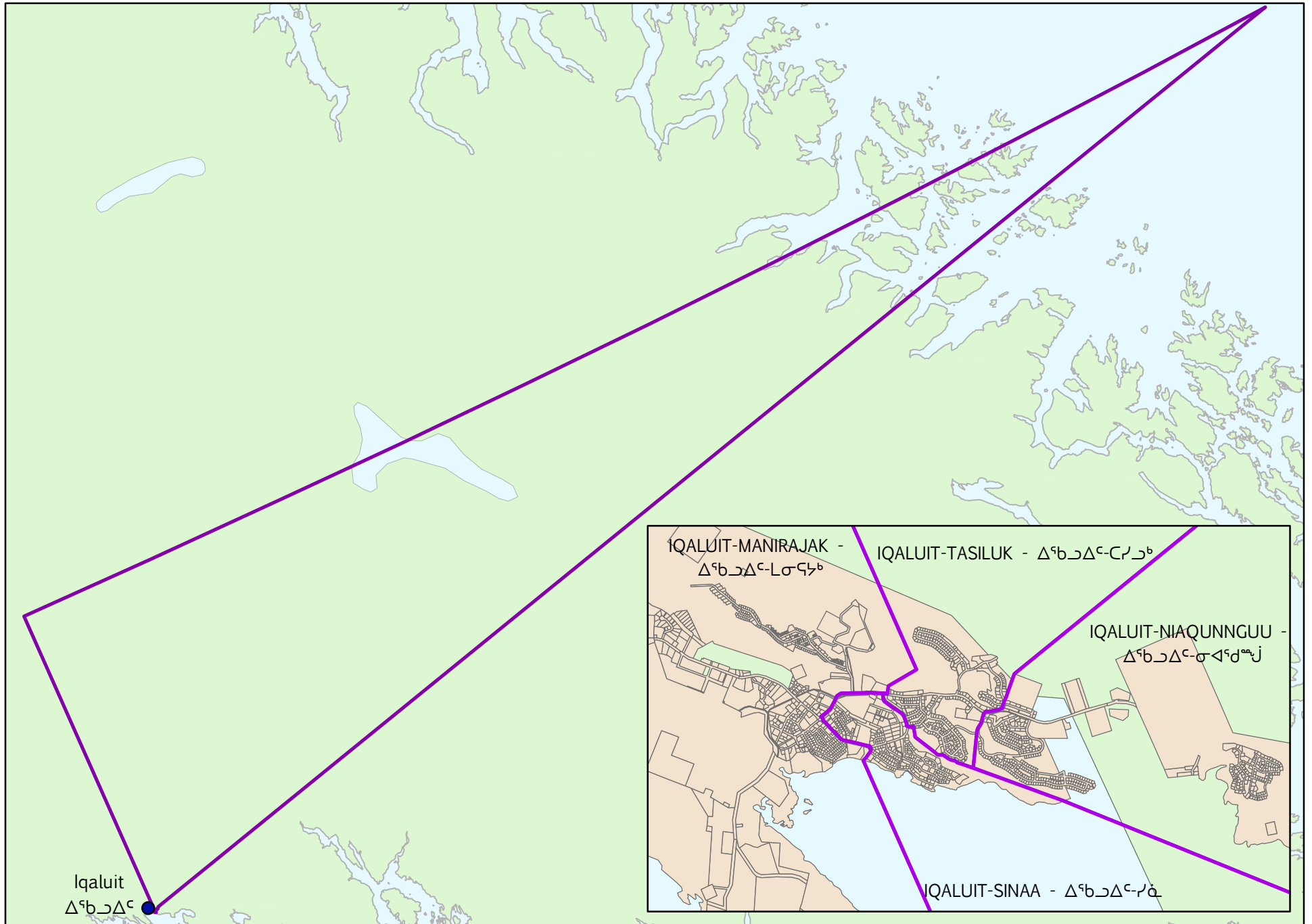

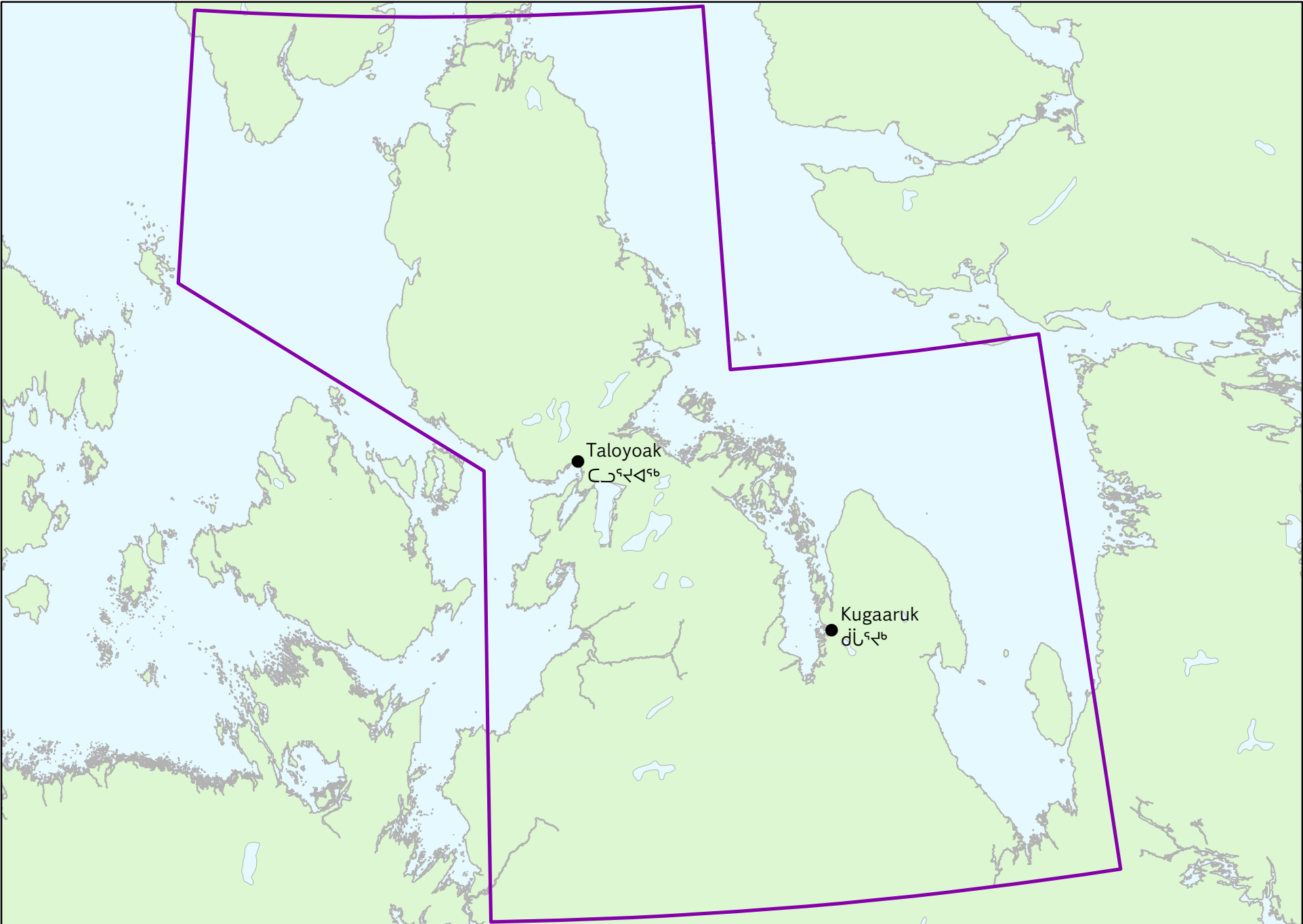

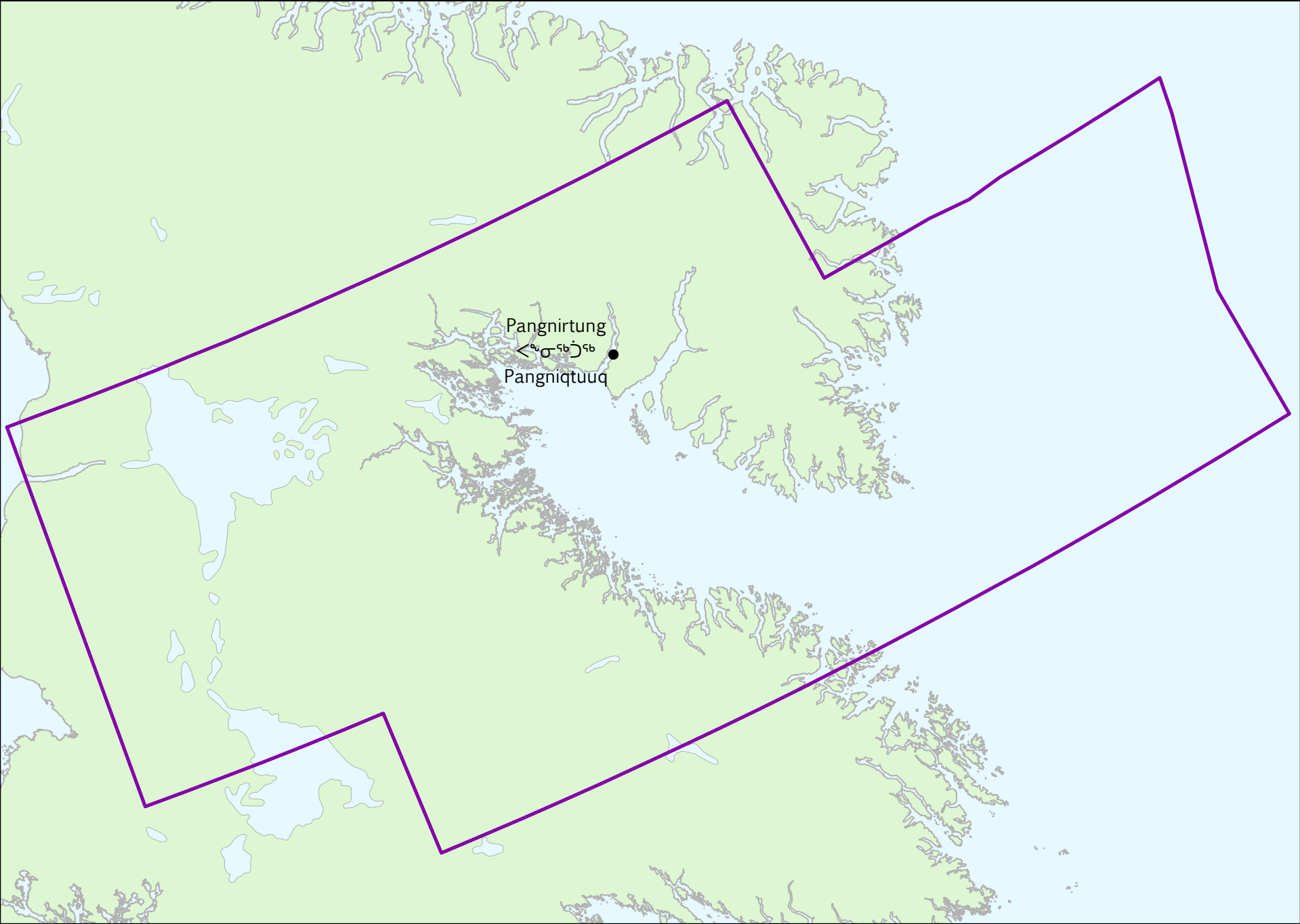

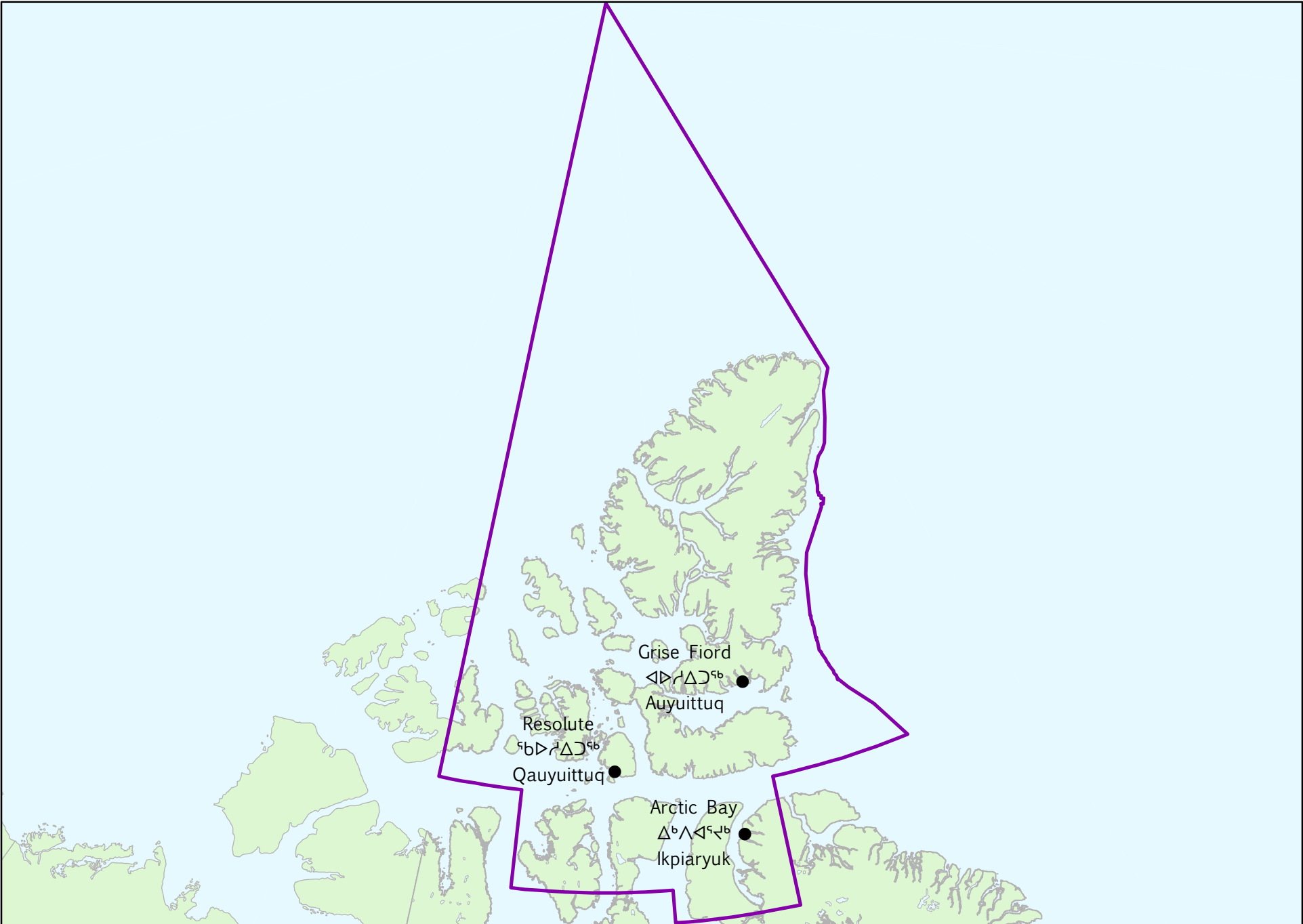

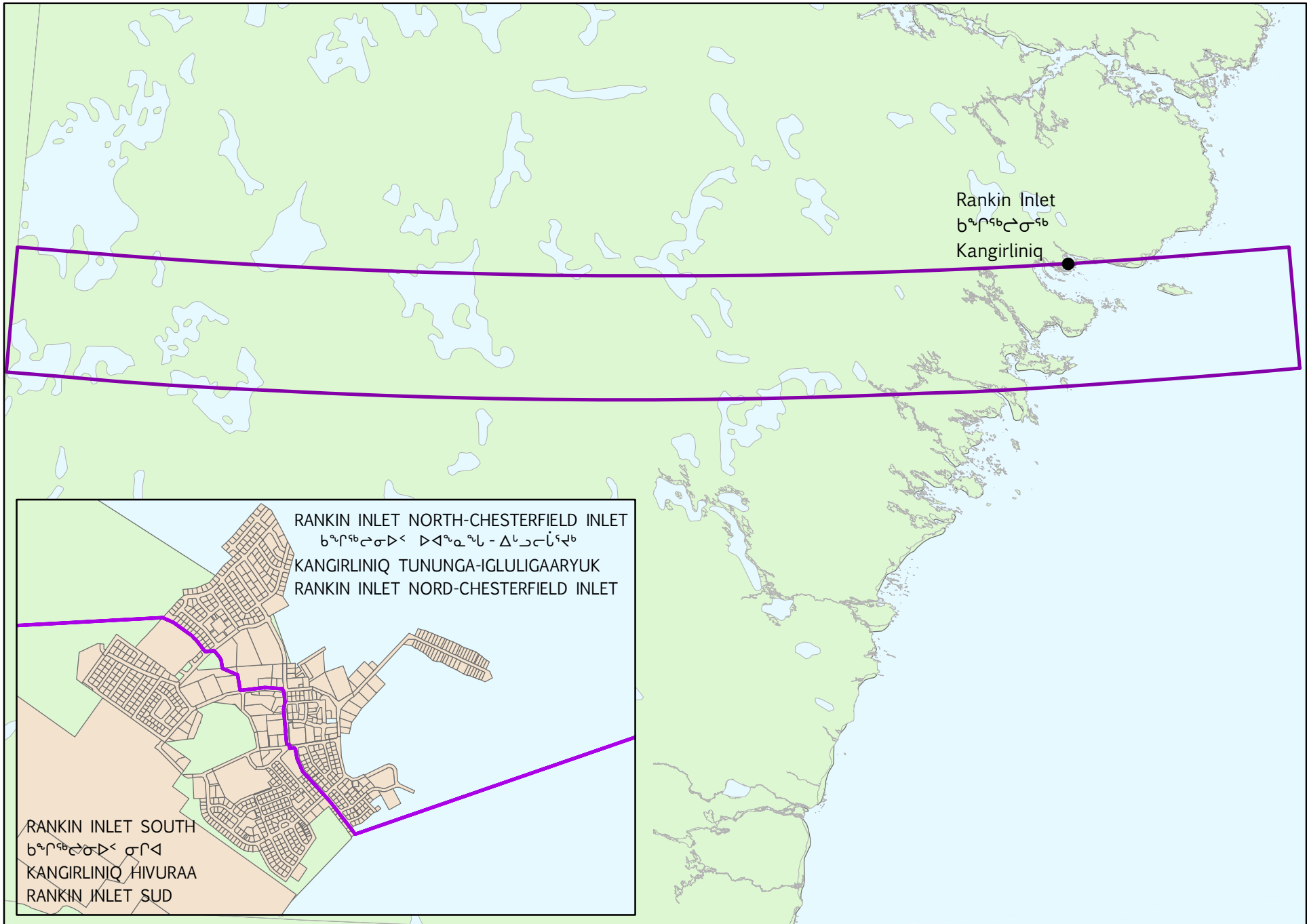

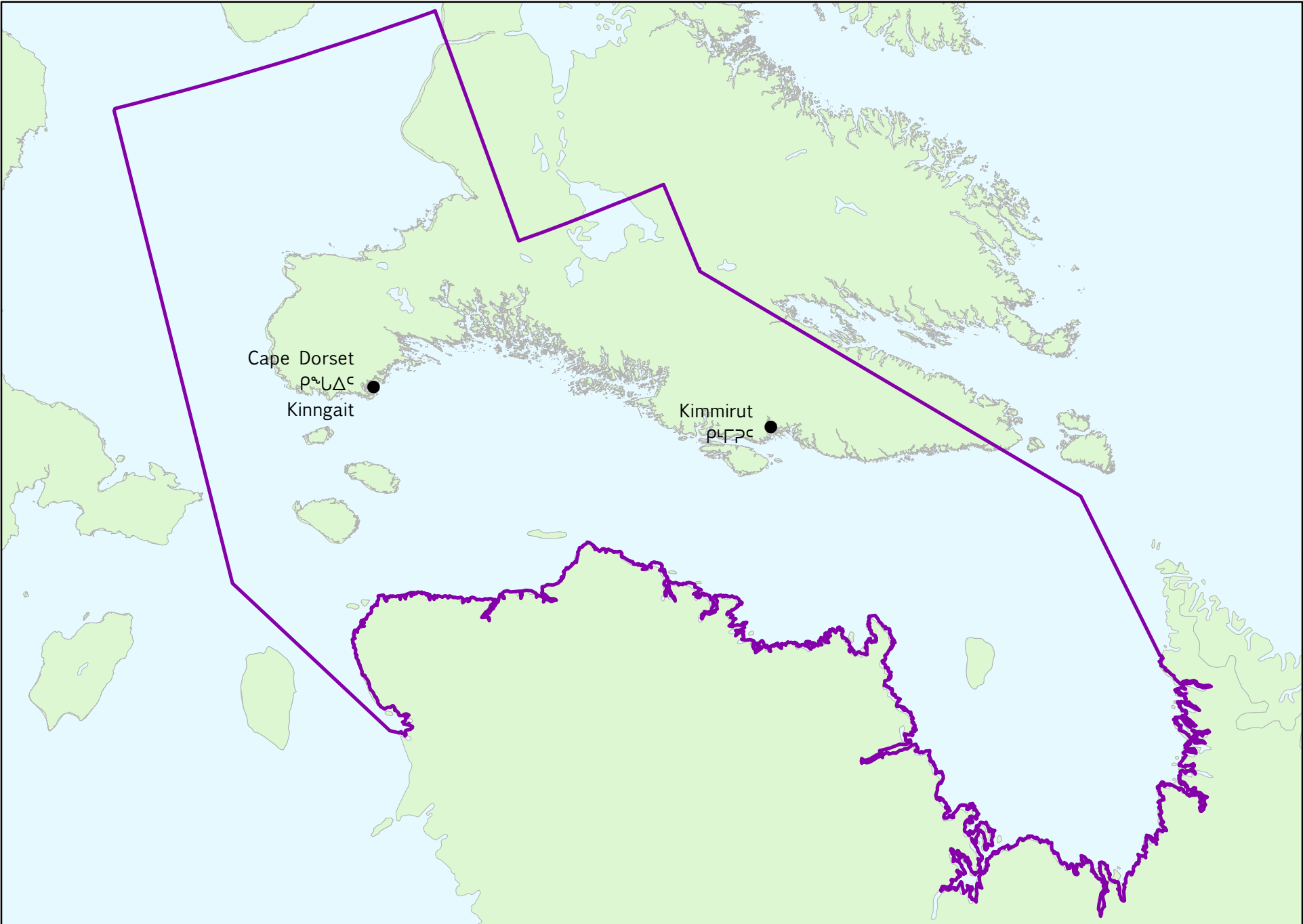
