WORKERS' COMPENSATION GENERAL REGULATIONS, amendment

The Commissioner, on the recommendation of the Minister, under section 169 of the *Workers' Compensation Act* and every enabling power, makes the annexed amendment to the *Workers' Compensation General Regulations*, Nu.Reg R-017-2010.

1. These regulations amend the *Workers' Compensation General Regulations*, Nu.Reg R-017-2010.

2. Section 1 is amended

- (a) in paragraphs (a) and (c) by replacing "\$94,500" wherever it appears with "\$97,300"; and
- (b) in paragraph (b) by replacing "\$46,725" with "\$48,109".

3. Subsection 4(3) is amended by replacing "\$0.615" with "\$0.590".

4. (1) Subsection 6(2) is repealed and replaced by:

(2) Despite subsection (1), the subsistence allowance under that subsection is reduced as to the following amounts if the worker is staying in accommodations in which kitchen facilities are available for use by the worker:

- (a) for meals,
 - (i) 75% of the amount payable in accordance with the Schedule for each of the 31st to 120th days of a continuous period that the worker is away from the worker's residence, and
 - (ii) 50% of the amount payable in accordance with the Schedule for every day after the 120th day of a continuous period that the worker is away from the worker's residence;
- (b) for incidental expenses, 75% of the amount payable in accordance with the Schedule for every day after the 30th day of a continuous period that the worker is away from the worker's residence.

(2) Paragraph 6(3)(b) is repealed and replaced by:

- (b) for overnight non-commercial accommodation,
 - (i) \$50 for each of the first 120 days of a continuous period that the worker is away from the worker's residence; and
 - (ii) \$25 for every day after the 120th day of a continuous period that the worker is away from the worker's residence.

5. The Schedule is repealed and replaced with the Schedule set out in the Appendix to these regulations.

6. These regulations come into force on the later of January 1, 2021 and the day on which they are registered by the Registrar of Regulations.
