ELECTIONS REGULATIONS, amendment

The Management and Services Board, under subsection 217(1) of the *Nunavut Elections Act* and every enabling power, makes the annexed amendments to the *Elections Regulations*, registered as regulation numbered R-025-2003.

1. **The *Elections Regulations*, registered as regulation numbered R-025-2003, are amended by these regulations.**

2. **Section 2 is amended by adding the following after paragraph (e):**
 - (f) a toll-free number to call for more information.

3. **Section 5.1 is amended by striking out "public notice of revision" and substituting "public notice of the voters list".**

4. **Subsection 7(1) is amended by striking out "on a registration form approved by the Chief Electoral Officer" and substituting "in the approved registration form".**

5. **Paragraph 8(1)(a) is repealed and the following substituted:**
 - (a) be in the approved form; and

6. **Section 9 is repealed and the following substituted:**

9. The printed copies of the voters list must be in Form 4 of the Schedule.

7. **Section 10 is repealed.**

8. **Section 11 is amended by striking out "a form approved by the Chief Electoral Officer" and substituting the following "the approved form".**

9. **Section 12 and the heading "Application to Vote on Election Day" immediately preceding it, are repealed and the following substituted:**

Registration at Place of Voting

12. The procedure for the registration of a voter under section 65 of the Act is the same as for the registration of a voter under section 7 of these Regulations.

10. **Paragraph 13(1)(d) is amended by striking out "two".**

11. Section 16.2 is amended by

(a) adding the following after subsection (1):

(1.1) The candidate must give written notice to the returning officer of the revocation and new appointment without delay.

(b) striking out that part of subsection (2) preceding paragraph (a) and substituting the following:

(2) The notice of the revocation and new appointment must include the following:

12. Subsection 17(1) is amended by striking "election notice" and substituting "election notice under section 84 of the Act".

13. Section 18 is repealed and the following substituted:

18. (1) The ballot must be in Form 7 of the Schedule.

(2) The special ballot must be in Form 8 of the Schedule.

14. Section 19 is amended by

(a) striking out "official" from paragraph (a);

(b) striking out "official" from paragraph (g); and

(c) striking out "on election day" and substituting "at the place of voting" in paragraph (i).

15. Section 21 is amended by

(a) striking out "official" from paragraph (c); and

(b) striking out "at the poll or who come with transfer certificates" and substituting "at the place of voting" in paragraph (d).

16. Section 22 is amended by

(a) repealing paragraph (c);

(b) repealing paragraph (e); and

(c) repealing paragraph (f) and substituting the following:

(f) the name of each voter who received assistance to vote and, opposite to the voter's name, the name of the person who provided the assistance and the relationship with the voter, if any;

17. The English version of subsection 25(1) is amended by striking out "advance poll" and substituting "advance vote".

18. Form 3 is repealed and Form 3 as set out in the Schedule to these regulations substituted.

19. Form 4 is amended by striking out "PRELIMINARY".

20. Form 5 is repealed.

21. The Schedule is amended by adding Form 8, as set out in the Schedule to these regulations, after Form 7.

INSPECTION OF VOTERS LIST

Any voter may inspect the voters list at an office of the Returning Officer on during office hours.

OBJECTIONS TO THE VOTERS LIST

Any person may object to a person being on a voters list as follows:

- You must put the objection in writing:
 - State your name, postal address and phone number
 - State the name of the person you object to
 - State the reason why that person is not qualified vote
- Send your objection to the office of the Chief Electoral Officer:
