PUBLIC COLLEGE FOR THE EASTERN ARCTIC REGULATIONS, amendment

The Commissioner in Executive Council, on the recommendation of the Minister, under section 34 of the *Public Colleges Act* and every enabling power, makes the annexed amendment to the *Public College for the Eastern Arctic Regulations*, registered under the *Statutory Instruments Act* (Northwest Territories), as regulation numbered R-119-94, as duplicated for Nunavut by section 29 of the *Nunavut Act*.

- 1. The *Public College for the Eastern Arctic Regulations*, registered under the *Statutory Instruments Act* (Northwest Territories) as regulation numbered R-119-94, as duplicated for Nunavut by section 29 of the *Nunavut Act*, are amended by these regulations.
- 2. The title is repealed and the following substituted:

NUNAVUT ARCTIC COLLEGE REGULATIONS

- 3. The definition "Board of Governors" in section 1 is amended by striking out "public college for the eastern arctic" and substituting "Nunavut Arctic College".
- 4. The following is added after section 6:
- 7. (1) The Board of Governors shall forward the name of each proposed member of the Science Advisory Council to the Minister, and if the Minister consents, the Board of Governors may make the appointment.
 - (2) The Science Advisory Council shall consist of not less than five and not more than 20 members.
- (3) A member may be appointed to the Science Advisory Council for a term not exceeding three years, but a member may be removed before the expiry of his or her term where, in the opinion of the Board of Governors, the removal of the member would be in the best interests of the Council.
- (4) The Board of Governors shall appoint members to the Science Advisory Council so as to ensure that the Science Advisory Council collectively holds the following qualifications:
 - (a) knowledge of scientific research methods;
 - (b) experience in conducting scientific research in general;
 - (c) experience in conducting scientific research in Nunavut;
 - (d) understanding of the issues facing scientific researchers in Nunavut;
 - (e) expertise in multiple fields of scientific endeavour;
 - (f) familiarity with other academic institutions;
 - (g) knowledge of Inuit societal values;
 - (h) knowledge of the guiding principles and concepts of Inuit Qaujimajatuqangit, as defined in the *Wildlife Act*;
 - (i) understanding of regional issues in Nunavut.
- (5) The members of the Science Advisory Council shall elect a chairperson and a vice-chairperson from among themselves.
