LIQUOR REGULATIONS, amendment

The Commissioner, on the recommendation of the Minister, under sections 11 and 54 of the *Liquor Act* and every enabling power, makes the annexed amendment to the *Liquor Regulations*, R.R.N.W.T. 1990, c.L-34, as duplicated for Nunavut by section 29 of the *Nunavut Act*.

- 1. The *Liquor Regulations*, R.R.N.W.T. 1990, c.L-34, as duplicated for Nunavut by section 29 of the *Nunavut Act*, are amended by these regulations.
- 2. Each provision listed in Column 1 of Schedule A to these regulations is amended by striking out the word or words set out in the same row of Column 2 of the Schedule, wherever they appear, and substituting the word or words set out in the same row of Column 3 of the Schedule.
- **3. Paragraph 10(a) is amended by striking out** ", the *Excise Act* (Canada) or the *Northwest Territories Act* (Canada)," **and substituting** "or the *Excise Act* (Canada)".
- 4. Subsection 32(2) is amended by striking out "during Indian band council elections, and".
- **5. Paragraph 62(a) is amended by striking out** ", the *Excise Act* (Canada) or the *Northwest Territories Act* (Canada)" **and substituting** "or the *Excise Act* (Canada)".
- 6. (1) Subsection 102(1) is amended by
 - (a) striking out "where a liquor warehouse has been established under section 70 of the Act" and substituting "where a liquor store or liquor warehouse has been established"; and
 - (b) striking out "the warehouse" and substituting "the liquor store or liquor warehouse".
- (2) Subsection 102(2) is amended by striking out "to the warehouse under (1)" and substituting "to the liquor store or liquor warehouse under subsection (1)".
- (3) Subsection 102(3) is amended by striking out "liquor warehouse" and substituting "liquor store or liquor warehouse".
- 7. Section 106 and the English version of the heading preceding section 106 are repealed and the following is substituted:

Liquor Import Permit

- 106. The expiration date of a liquor import permit shall be 21 days from the date of issue, unless stated otherwise.
- 8. Forms 8 and 9 of Schedule A are repealed and the forms set out in Schedule B to these regulations are substituted.
- 9. Item 1 of Schedule C is amended by striking out "an imported liquor permit" and substituting "a liquor import permit".
