### LIQUOR REGULATIONS, amendment

The Liquor Licensing Board, under section 11 of the *Liquor Act* and every enabling power, makes the annexed amendment to the *Liquor Regulations*, R.R.N.W.T. 1990, c.L-34, as duplicated for Nunavut by section 29 of the *Nunavut Act*.

# 1. The *Liquor Regulations*, R.R.N.W.T. 1990, c.L-34, as duplicated for Nunavut by section 29 of the *Nunavut Act*, are amended by these regulations.

#### 2. Section 1 is amended by adding the following definitions in alphabetical order:

"Fire Marshal" means the Fire Marshal appointed under the Fire Prevention Act; (commissaire aux incendies)

"Health Officer" means a Health Officer appointed under the *Public Health Act*; (agent de la santé)

## 3. Section 8 is repealed and the following is substituted:

- 8. An application for the renewal of a commercial licence shall be
  - (a) in Form 1A of Schedule A;
  - (b) accompanied by a letter from the Fire Marshal attesting that the licensed premises are in compliance with the *Fire Prevention Act* and the regulations made under that Act; and
  - (c) accompanied by a letter from a Health Officer attesting that the licensed premises are in compliance with the *Public Health Act* and the regulations made under that Act.

#### 4. Section 12 is repealed and the following is substituted:

- 12. An application for the renewal of a club licence shall be
  - (a) in Form 2 of Schedule A; and
  - (b) accompanied by
    - (i) a list of officers of the club,
    - (ii) a financial statement prepared by independent auditors respecting the last fiscal period of the club,
    - (iii) a letter from the Fire Marshal attesting that the licensed premises are in compliance with the *Fire Prevention Act* and the regulations made under that Act,
    - (iv) a letter from a Health Officer attesting that the licensed premises are in compliance with the *Public Health Act* and the regulations made under that Act, and

(v) the renewal fee set out in Schedule B.

#### 5. Paragraph 128(c) is repealed and the following is substituted:

- (c) a letter from
  - (i) the Fire Marshal attesting that the premises of the licence holder are in compliance with the *Fire Prevention Act* and the regulations made under that Act, and
  - (ii) a Health Officer attesting that the premises of the licence holder are in compliance with the *Public Health Act* and the regulations made under that Act; and

## 6. Paragraph (a) of the French version of Schedule D is repealed and the following is substituted:

- a) deux consommations à l'heure, chacune ayant un volume :
  - i) de 341 ml, dans le cas d'une bière,
  - ii) de 43 ml, dans le cas d'un spiritueux,
  - iii) de 142 ml, dans le cas du vin;
