**DRIVER'S LICENCE REGULATIONS, amendment**

The Minister, under sections 349 and 350 of the *Traffic Safety Act*, R.S.N.W.T. 1988,c.M-16, and every enabling power, makes the annexed amendments to the *Driver's Licence Regulations*, R.R.N.W.T. 1990,c.M-27.

**1. The *Driver's Licence Regulations*, R.R.N.W.T. 1990,c.M-27, are amended by these regulations.**

**2. The following is added after section 4 and after the heading "Standards":**

4.1. (1) "Examination Standard" means Standard 2 "Knowledge and Performance of Tests (Drivers)" of the "National Safety Code for Motor Carriers" published by the Canadian Council of Motor Transport Administrators. (*norme concernant les épreuves*)

(2) The Examination Standard, as amended from time to time, is adopted by these regulations.

(3) The theoretical and practical driving examinations must be made in accordance with the minimum requirements for testing provided in the Examination Standard.

**3. Section 6 is amended**

**(a) by repealing and replacing subsection (1) with**

(1) "Medical Standard" means Standard 6 "Determining Driver Fitness in Canada" of the "National Safety Code for Motor Carriers" published by the Canadian Council of Motor Transport Administrators. (*norme médicale*)

**(b) by replacing "Standard" wherever it appears with "Medical Standard".**

**4. Section 8 is repealed and replaced by:**

8. (1) Subject to subsection (2), a driver's licence expires on the birthday of the license holder in the fifth year after the end of the year in which the licence is issued.

(2) A driver's licence expires on the birthday of the license holder in the tenth year after the end of the year in which the licence is issued if

(a) the licence holder chooses this option at the time the driver's licence is issued; and

(b) the licence holder is an adult at the time the driver's licence is issued.

**5. Schedule E is repealed and replaced with the schedule set out in Appendix 1 to these regulations.**
