## MUSKOX TOTAL ALLOWABLE HARVEST ORDER

The Minister, in accordance with an accepted decision of the NWMB, under sections 120, 121, 156, 157 and 201 of the *Wildlife Act* and every enabling power, makes the annexed *Muskox Total Allowable Harvest Order*.

1. (1) A total allowable harvest is established for muskox in accordance with this Order.

(2) The level of the total allowable harvest is set out in column 3 of Schedule A and, subject to subsection (2.1), is expressed as a yearly limit allocated to a Muskox Management Zone and, where indicated, to a region.

(2.1) The level of the total allowable harvest for the Devon Group Muskox Management Zone is a flexible limit and unused tags may be carried forward for a maximum of three years.

(3) It is presumed that Inuit need the total allowable harvest established for muskox. R-003-2018; R-007-2022,s.2.

**2.** (1) The populations of muskox that are recognized in Nunavut are pictured in a map set out in Schedule B, using the abbreviations for the populations.

(2) A muskox found inside Nunavut within 30 km of the boundary of a muskox population may be presumed to come from either the population of the area it was found in or from the bordering one.

**3.** The following regulations are repealed:

- (a) the *Big Game Hunting Regulations*, registered under the *Statutory Instruments Act* (Northwest Territories) as regulation numbered R-019-92, as duplicated for Nunavut by section 29 of the *Nunavut Act* (Canada); and
- (b) the Wildlife Management Muskox Areas Regulations, R.R.N.W.T. 1990,
  c.W-11 as duplicated for Nunavut by section 29 of the Nunavut Act (Canada).


