Chapter 6

MISCELLANEOUS STATUTES AMENDMENT ACT (Assented to May 31, 2024)

The Commissioner, by and with the advice and consent of the Legislative Assembly, enacts as follows:

1. Sections 5 and 10 of the *Age of Majority Act* are repealed.

2. The *Boards of Management Dissolution Act* is repealed.

3. Sections 4 and 6 of the *International Child Abduction Act* are amended by replacing "Minister responsible for justice" with "Minister of Justice".

4. (1) Sections 2 and 55 of the *Liquor Act* are repealed.

(2) Subsection 80(2) of the *Liquor Act* is amended by replacing "Minister responsible for the administration of justice in Nunavut" with "Minister of Justice".

5. Subsection 5.1(2) of the *Medical Care Act* is repealed.

- 6. The *NWT Energy Corporation Ltd. Loan Guarantee Act* is repealed.
- 7. (1) The *Payroll Tax Act, 1993* is renamed the *Payroll Tax Act.*

(2) The definition of "judge" in section 1 of the *Payroll Tax Act* is repealed.

8. The definition of "public authority" in section 1 of the *Planning Act* is amended by deleting ", school board, hospital board".

9. The Transportation of Dangerous Goods Act, 1990 is renamed the Transportation of Dangerous Goods Act.

10. (1) The definitions of "Court of Appeal", "Financial Management Board", "judge", "Minister", "Nunavut Court of Justice", "prescribed" and "public service" are repealed where they appear in the following provisions:

- (a) section 2 of the Access to Information and Protection of Privacy Act;
- (b) section 1 of the *Arbitration Act*;
- (c) section 1 of the *Cities*, *Towns and Villages Act*;
- (d) section 1 of the *Commercial Tenancies Act*;
- (e) section 1 of the *Commissioner's Land Act*;
- (f) section 1 of the *Coroners Act*;
- (g) section 1 of the *Creditor's Relief Act*;
- (h) section 1 of the *Defamation Act*;
- (i) section 1 of the *Dependants Relief Act*;

- (j) section 1 of the *Expropriation Act*;
- (k) section 1 of the *Fatal Accidents Act*;
- (l) section 1 of the *Hamlets Act*;
- (m) section 1 of the Interjurisdictional Support Orders Act;
- (n) section 1 of the *Judicature Act*;
- (o) section 1 of the *Jury Act*;
- (p) section 1 of the *Land Titles Act*;
- (q) section 1 of the *Marriage Act*;
- (r) section 1 of the *Mechanics Lien Act*;
- (s) section 1 of the Northern Employee Benefits Services Pension Plan Act;
- (t) section 1 of the *Nunavut Development Corporation Act*;
- (u) section 55 of the *Public Service Act*;
- (v) section 1 of the *Qulliit Nunavut Status of Women Council Act*;
- (w) subsection 1(1) of the *Residential Tenancies Act*;
- (x) section 1 of the *Seizures Act*;
- (y) section 1 of the *Tobacco Tax Act*;
- (z) subsection 1(1) of the *Trustee Act*;
- (aa) section 2 of the *Wildlife Act*.

(2) Section 1 of the *Contributory Negligence Act* is repealed.
