## Chapter 19

# WRITE-OFF OF ASSETS AND DEBTS ACT, 2023-2024

(Assented to November 7, 2024)

The Commissioner, by and with the advice and consent of the Legislative Assembly, enacts as follows:

# Write-off of debts

1. The debts owed to the Government of Nunavut that are listed in Part 1 of the Schedule are written off.

#### Write-off of assets

2. The assets of the Government of Nunavut that are listed in Part 2 of the Schedule are written off.

#### Write-off of debts

**3.** The debts owed to the Nunavut Housing Corporation that are listed in Part 3 of the Schedule are written off.

## Write-off of assets

**4.** The assets of the Nunavut Housing Corporation that are listed in Part 4 of the Schedule are written off.

#### Write-down of assets

**5.** The assets of the Nunavut Housing Corporation that are listed in Part 5 of the Schedule are written down.
