DRIVER'S LICENCE REGULATIONS, amendment

The Minister, under section 349 of the *Traffic Safety Act*, and every enabling power, makes the annexed amendments to the *Driver's Licence Regulations*, R.R.N.W.T. 1990,c.M-27.

- 1. These regulations amend the *Driver's Licence Regulations*, R.R.N.W.T. 1990,c.M-27.**
- 2. Subsection 6(4) is repealed and replaced by**
 - (4) A report prepared under the Act by a medical practitioner must
 - (a) include the information set out in Schedule C; and
 - (b) be signed by the medical practitioner.
- 3. Subsection 6(5) is repealed.**
- 4. Schedule C is repealed and replaced with Schedule C in the Schedule to these regulations.**

DRIVER'S MEDICAL EXAMINATION REPORT

1. The form for the driver's medical examination report must provide for the following information to be entered:
 - (a) the name, date of birth, and civic address of the applicant;
 - (b) whether the applicant has a history of the following, and if so, the details of that history:
 - (i) special sense disease (hearing loss, vertigo, visual defects, etc.),
 - (ii) cardiovascular disease (angina, infarction, heart failure, arrhythmia, stroke, etc.),
 - (iii) respiratory disease (asthma, chronic bronchitis, emphysema, etc.),
 - (iv) neurologic disease (epilepsy, Parkinson's disease, multiple sclerosis, etc.),
 - (v) metabolic disease (diabetes, thyroid disease, etc.),
 - (vi) psychiatric disease (psychoneurosis, psychosis, etc.),
 - (vii) addictions (alcohol, sedatives, tranquilizers, narcotics, etc.),
 - (viii) other diseases (black outs, fainting spells, severe anaemia, carcinoma, blood dyscrasias, etc.);
 - (c) whether the applicant is taking any medication, and if so, the specifics;
 - (d) the height, weight, systolic blood pressure, and diastolic blood pressure of the applicant;
 - (e) whether the applicant had normal urine or abnormal urine, and if abnormal, the specifics of the abnormality;
 - (f) the specifics of any other tests conducted on the applicant, and the findings of those tests;
 - (g) the applicant's vision, without the use of glasses, in the right eye and left eye;
 - (h) the applicant's vision, with the use of glasses, in the right eye and left eye;
 - (i) whether the applicant's peripheral vision is normal or defective;
 - (j) whether the applicant's colour vision is normal, defective, or defective safe;
 - (k) whether the applicant has any of the following, and if so, the details:
 - (i) eye disease,
 - (ii) ear disease,
 - (iii) respiratory disease,
 - (iv) cardiovascular disease, and if so, the degree of compensation,
 - (v) gastro-intestinal disease,
 - (vi) neurologic disease,
 - (vii) skeletal disease,
 - (viii) psychiatric disease;

- (l) whether the applicant has been prescribed any medication, and if so, the details;
- (m) whether the applicant met the medical standards for the class of licence requested, and if not, the reasons the applicant did not;
- (n) whether the medical practitioner wishes for the applicant to receive a second medical opinion, and if so, whether the medical practitioner wishes to arrange the second medical opinion; and
- (o) the location where the medical examination was conducted.
