Chapter 7

MISCELLANEOUS STATUTES AMENDMENT ACT, 2009 (Assented to June 16, 2009)

The Commissioner of Nunavut, by and with the advice and consent of the Legislative Assembly, enacts as follows:

Adoption Act

1. (1) The *Adoption Act* is amended by this section.

(2) Subsection 1(1) is amended by

(a) adding the following definition in alphabetical order:

"Clerk" means the Clerk of the Nunavut Court of Justice appointed under the *Judicature Act*; (*greffier*)

(b) repealing the definition "court" and substituting the following:

"court" means the Nunavut Court of Justice; (tribunal)

- (c) adding "(*registraire général*)" after the English version of the definition "Registrar General".
- (d) striking out "(registre des adoptions)" and substituting "(renseignements déposés)" after the English version of the definition "registry information".

(3) Each provision listed in Column 1 of Schedule A to this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Family Abuse Intervention Act

2. (1) The *Family Abuse Intervention Act* is amended by this section.

(2) Subsection 48(1) is amended by adding "or community intervention orders" after "emergency protection orders".

(3) This section is deemed to have come into force March 1, 2008.

Financial Administration Act

3. (1) The *Financial Administration Act* is amended by this section.

(2) Items 2 and 4 of Schedule A to the Act are repealed.

(3) Each provision listed in Column 1 of Schedule B to this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Planning Act

4. (1) The *Planning Act* is amended by this section.

(2) Section 11 is amended by striking out "Yellowknife" wherever it appears and substituting "Iqaluit".

(3) Subsection 11(1) is amended by striking out "the Territories" and substituting "Nunavut".

(4) Subsection 40(7) is amended by striking out "Government of the Northwest Territories" and substituting "Government of Nunavut".

(5) Each provision listed in Column 1 of Schedule C to this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Public Service Act

5. (1) The *Public Service Act* is amended by this section.

(2) The definition "annual vacation leave" in subsection 1(1) is repealed.

(3) Subsection 34(8) is amended by striking out "Northwest Territories Gazette" and substituting "Nunavut Gazette".

(4) The following provisions are amended by striking out "Nunavut Power Corporation" wherever it appears and substituting "Qulliq Energy Corporation":

- (a) paragraphs 41(1.4)(a) and (b);
- (b) subsections 41(1.7) and (1.8).

(5) Paragraphs (c) and (d) of Schedule A are repealed.

(6) Paragraph (j) of Schedule B is repealed.

Public Trustee Act

6. (1) The *Public Trustee Act* is amended by this section.

(2) Section 1 is amended by adding the following definitions in alphabetical order:

"Clerk" means the Clerk of the Nunavut Court of Justice appointed under the *Judicature Act*; (*greffier*)

"court" means the Nunavut Court of Justice; (tribunal)

(3) Subsection 28(2) is repealed and the following substituted:

Power to appoint

(2) The court may by order appoint the Public Trustee a judicial trustee where, in the opinion of the court, it is expedient to do so.

(4) Subsection 34(1) is repealed and the following substituted:

Application to require passing of accounts

34. (1) The Public Trustee may, in the following circumstances, apply to the court to compel an administrator or executor acting in the affairs of an estate in which the Public Trustee is interested to pass his or her accounts:

- (a) at the expiration of two years after the date on which probate or letters of administration were issued; or
- (b) at any other time when the Public Trustee considers it advisable.

(5) Each provision listed in Column 1 of Schedule D to this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.
