Chapter 9

SUPPLEMENTARY APPROPRIATION (OPERATIONS AND MAINTENANCE) ACT, NO. 1, 2020-2021 (Assented to September 28, 2020)

Whereas it appears by message from the Commissioner and from the estimates accompanying the message, that the amounts set out in the Schedule to this Act are required to defray the operations and maintenance expenses of the Government of Nunavut and for other purposes connected with the Government of Nunavut for the fiscal year ending March 31, 2021;

Therefore, the Commissioner of Nunavut, by and with the advice and consent of the Legislative Assembly, enacts as follows:

Definitions

1. The definitions in section 1 of the *Financial Administration Act* apply to this Act.

Application

2. This Act applies to the fiscal year ending on March 31, 2021.

Supplementary appropriations

3. In addition to the amounts authorized by the *Appropriation (Operations and Maintenance) Act, 2020-2021* there may be expended from the Consolidated Revenue Fund, in accordance with the *Financial Administration Act*, the amount set out as supplementary appropriations for the item in the Schedule.

Purpose of appropriation

4. The amount set out as supplementary appropriations for the items in the Schedule may be expended only for the purpose of defraying the operations and maintenance expenses of the Government of Nunavut and for other purposes connected with the Government of Nunavut, in accordance with the Schedule.

Lapse of appropriation

5. Subject to sections 36 and 37 of the *Financial Administration Act*, the authority in this Act to make expenditures for the purposes and in the amount set out in the Schedule expires on March 31, 2021.

Accounting

6. Amounts expended under the authority of this Act shall be accounted for in the Public Accounts in accordance with sections 72 and 73 of the *Financial Administration Act*.

Special Warrants

- **7.** The expenditures authorized in the following Special Warrants are amended as follows:
 - (a) *Special Warrant, 2020-2021*, registered as SI-004-2020, is amended by reducing the authorized expenditure for the purposes of Executive and Intergovernmental Affairs from \$5,423,000 to \$423,000;
 - (b) *Special Warrant No. 2, 2020-2021,* registered as SI-005-2020, is amended by reducing the authorized expenditure for the purposes of Executive and Intergovernmental Affairs from \$1,030,000 to \$0; and
 - (c) *Special Warrant No.* 8, 2020-2021, registered as SI-013-2020, is amended by reducing the authorized expenditure for the purposes of Finance from \$4,100,000 to \$0.

Commencement

8. This Act is deemed to have come into force on April 1, 2020.
