WORKERS' COMPENSATION GENERAL REGULATIONS, amendment (2019)

The Commissioner, on the recommendation of the Minister, under section 169 of the *Workers' Compensation Act* and every enabling power, makes the annexed amendment to the *Workers' Compensation General Regulations*, registered as regulation numbered R-017-2010.

1. The Workers' Compensation General Regulations, established by regulation numbered R-017-2010, are amended by these regulations.

2. (1) Paragraphs 1(a) and (c) are each amended by replacing "\$90,600" with "\$92,400".

(2) Paragraph 1(b) is amended by replacing "\$44,797" with "\$45,687".

3. Subsection 4(3) is amended by replacing "\$0.585" with "\$0.590".

4. Section 6 is repealed and the following is substituted:

6. (1) For every day of a continuous period that a worker is away from the worker's place of residence, the subsistence allowance for meals and incidental expenses to which the worker is entitled under paragraph 47(1)(a) of the Act is payable in accordance with the Schedule.

(2) Despite subsection (1), for every day after the 30th day of a continuous period that a worker is away from the worker's place of residence, if the worker is staying in accommodations in which kitchen facilities are available for use by the worker, the subsistence allowance for meals and incidentals to which the worker is entitled under paragraph 47(1)(a) of the Act is 75% of the amount payable in accordance with the Schedule.

(3) The daily subsistence allowance for overnight accommodations to which a worker is entitled under paragraph 47(1)(a) of the Act is,

- (a) for overnight commercial accommodation, if the Commission has pre-approved the accommodation and a receipt is provided to the Commission, the amount charged by the provider of the accommodation;
- (b) for overnight non-commercial accommodation \$50.

(4) The Commission shall pay to a person escorting a worker referred to in paragraph 47(1)(a) of the Act, a subsistence allowance equal to that payable to the worker under subsections (1) to (3), if the Commission is satisfied that

- (a) the person accompanying the worker is necessary for the provision of medical aid; and
- (b) the person who escorts the worker is a suitable person.

(5) No subsistence allowance is payable to a worker for a period during which the worker is being provided by the Commission with board and lodging in a hospital or other place of treatment.

5. The Schedule set out in the Appendix to these regulations is added.
