### NUNAVUT ACT Commissioner of Nunavut SI-008-99

### Registered with the Registrar of Regulations

**April 1, 1999** 

#### Order

#### The Commissioner orders that:

Whereas the Acting Interim Commissioner has reported that there are general and necessary government expenditures, as set out in the Schedule, for which there is no other lawful authority to defray;

And whereas the Acting Interim Commissioner has reported that he estimates that the sums set out in the Schedule are the sums required for the period of three\_consecutive months beginning April 1, 1999 for the general and necessary government expenditures for which there is no other lawful authority to defray;

And whereas section 70 of the Nunavut Act (Canada) provides that, until the first Legislative Assembly is convened, the Commissioner of Nunavut may authorize the payment of monies out of the Nunavut Consolidated Revenue Fund for the purposes of defraying expenses incurred in respect of Nunavut for which there is no other lawful authority to defray;

And whereas the Executive Council has not yet been formally appointed but its members have been selected by the members-elect of the Legislative Assembly and the persons selected to be members of the Executive Council have been consulted on the making of this Order;

And whereas the first Legislative Assembly has not yet been convened;

Therefore, under section 70 of the Nunavut Act (Canada), monies may be paid out of the Nunavut Consolidated Revenue Fund for the purposes of defraying the expenses set out in the Schedule for the three consecutive months beginning April 1, 1999.
