ESTABLISHMENT OF DEPARTMENTS AND RESPONSIBILITY FOR ACTS REGULATIONS

The Commissioner in Executive Council, on the recommendation of the Premier and, where applicable, with the consent of the Speaker, under sections 67.1 and 67.2 of the *Legislative Assembly and Executive Council Act* and every enabling power, makes the annexed *Establishment of Departments and Responsibility for Acts Regulations*.

Departments

1. (1) In addition to the Department of Justice established under the *Department of Justice Act*, the following departments of the Government of Nunavut are established:

- (a) the Department of Community and Government Services;
- (b) the Department of Culture and Heritage;
- (c) the Department of Economic Development and Transportation;
- (d) the Department of Education;
- (e) the Department of Environment;
- (f) the Department of Executive and Intergovernmental Affairs;
- (g) the Department of Family Services;
- (h) the Department of Finance;
- (i) the Department of Health;
- (j) the Department of Human Resources.

(2) Departments are assigned responsibilities, other than responsibility for the administration of Acts, in accordance with Schedule A.

Responsibility for the administration of Acts

2. (1) Subject to this section, responsibility for the administration of Acts is assigned in accordance with Schedule B.

(2) If a provision of an Act specifies the Minister that is to exercise a function, that Minister and their department or public agency is responsible for the administration of the provision and related provisions for the purpose of the exercise of the function.

(3) If a provision of an Act provides for the Premier or Executive Council to exercise a function, the Minister and Department of Executive and Intergovernmental Affairs are responsible for the administration of the provision and related provisions for the purpose of the exercise of the function.

(4) If a provision of an Act provides for the Financial Management Board to exercise a function, the Minister and Department of Finance is responsible for the administration of the provision and related provisions for the purpose of the exercise of the function.

(5) For greater certainty, nothing in this section or the Schedule affects existing prerogatives with respect to the introduction of Bills, including amending Bills, in the Legislative Assembly by a member of the Legislative Assembly, including a Minister.

 - (n) services to and programs for municipalities;

 - (i) business continuity,
 - (ii) fire prevention, and
 - (iii) search and rescue.

CULTURE AND HERITAGE

- 2. The Department of Culture and Heritage is responsible for
 - (a) government-wide alignment with Inuit Qaujimajatuqangit and Inuit societal values;
 - (b) government-wide official language strategies and policies;
 - (c) government-wide translation services;
 - (d) government-wide language training;
 - (e) protection, promotion and revitalization of the Inuit Language;
 - (f) relations with the Inuit Uqausinginnik Taiguusiliuqtiit;

- (g) conservation, protection, promotion and enhancement of culture, heritage and historical resources;
- (h) supporting community-lead projects that promote Inuit societal values;
- (i) public transfer of Inuit Qaujimajatuqangit, particularly from Elders to youth;
- (j) archaeology and palaeontology;
- (k) toponymy;
- (1) Nunavut Archives; and
- (m) public libraries.

ECONOMIC DEVELOPMENT AND TRANSPORTATION

- **3.** The Department of Economic Development and Transportation is responsible for
 - (a) economic and business development;
 - (b) supports to industry;
 - (c) sustainable development, diversification and promotion of primary industries;
 - (d) fisheries and sealing;
 - (e) geoscience and prospecting;
 - (f) distribution of country food;
 - (g) tourism and cultural industries;
 - (h) media, including film and television;
 - (i) national and international trade relations;
 - (j) transportation, including transportation infrastructure;
 - (k) development of transportation facility capital projects;
 - (1) providing support to the Nunavut Development Corporation and the Nunavut Business Credit Corporation;
 - (m) motor vehicles; and
 - (n) general identification cards.

EDUCATION

- 4. The Department of Education is responsible for
 - (a) primary and secondary education, including
 - (i) supports to district education authorities,
 - (ii) relations with the Coalition of Nunavut District Education Authorities,
 - (iii) recruitment and retention of teachers,
 - (iv) teacher certification,
 - (v) use of public school facilities,
 - (vi) public school programs, and
 - (vii) regulation of private school facilities and programs;
 - (b) regulation of early childhood education and child day care facilities and programs;
 - (c) regulation of adult learning, including post-secondary education; and
 - (d) student financial assistance.

ENVIRONMENT

- 5. The Department of Environment is responsible for
 - (a) environmental protection and environmental compliance;
 - (b) environmental science;
 - (c) environmental assessment;
 - (d) land use planning;
 - (e) wildlife management, including wildlife research;
 - (f) relations with Hunters and Trappers Organizations and Regional Wildlife Organizations;
 - (g) seal and fur purchase programs;
 - (h) territorial parks;
 - (i) protected areas;
 - (j) climate change adaptation and mitigation; and
 - (k) geographic information.

EXECUTIVE AND INTERGOVERNMENTAL AFFAIRS

- 6. The Department of Executive and Intergovernmental Affairs is responsible for
 - (a) management and coordination of the activities, responsibilities and business planning of the Government of Nunavut;
 - (b) government-wide strategic communications planning;
 - (c) coordination of relations with the federal government, provincial governments and other territorial governments;
 - (d) devolution;
 - (e) sustainable development;
 - (f) implementation and negotiation of agreements with Indigenous peoples and organizations, including the Nunavut Agreement;
 - (g) relationships with Indigenous, circumpolar and related international organizations, including Nunavut Tunngavik Incorporated and Regional Inuit Organizations;
 - (h) coordination of international relations;
 - (i) Government Liaison Officers;
 - (j) immigration;
 - (k) protocol;
 - (l) access to information and protection of privacy;
 - (m) statistics;
 - (n) the Cabinet Secretariat;
 - (o) the Senior Personnel Secretariat;
 - (p) administrative support to the Utility Rates Review Council; and
 - (q) administrative support to the Premier's Office, Ministers' Offices and the Commissioner's Office.

FAMILY SERVICES

- 7. The Department of Family Service is responsible for
 - (a) child protection;
 - (b) family support services including
 - (i) counselling,
 - (ii) in-home parenting support,
 - (iii) respite care,
 - (iv) parenting programs, and
 - (v) other family support services to assist the family to deal with the illness of a child or another family member;
 - (c) adoption and foster care;
 - (d) youth support services;
 - (e) poverty reduction;
 - (f) food security;
 - (g) protection of vulnerable adults, other than guardianship;
 - (h) income assistance and other benefit programs;
 - (i) career and labour market training;
 - (j) trades and occupations certification;
 - (k) emergency and transitional housing;
 - (1) residential care, other than those provided by the Department of Health;
 - (m) social service facilities;
 - (n) family violence services;
 - (o) adult support services;
 - (p) other assistance to individuals, families, groups and communities;
 - (q) family wellness; and
 - (r) labour market programs.

FINANCE

- 8. The Department of Finance is responsible for
 - (a) providing support to the Financial Management Board;
 - (b) fiscal policy;
 - (c) government finances, including comptrollership;
 - (d) government-wide expenditure management;
 - (e) government-wide internal audit;
 - (f) taxation including tax credits and benefits;
 - (g) insurance;
 - (h) liquor and cannabis management;
 - (i) compensation and benefits for public servants;
 - (j) energy subsidies; and
 - (k) supports to public agencies.

HEALTH

- 9. The Department of Health is responsible for
 - (a) public health;
 - (b) health care, mental health, personal care, rehabilitation, addictions and trauma-related services, including
 - (i) hospitals and other health facilities,
 - (ii) referrals to out-of-territory services, and
 - (iii) home and community care;
 - (c) medical transportation;
 - (d) oral health and dental care;
 - (e) residential long-term care;
 - (f) suicide prevention, intervention and postvention;
 - (g) healing programs;
 - (h) regulation of health professions;
 - (i) health information;
 - (j) health insurance; and
 - (k) vital statistics.

HUMAN RESOURCES

 - (k) human rights;
 - (1) government-wide legal and legislative services;
 - (m) correctional facilities, including
 - (i) correctional centres,
 - (ii) on-the-land camp operations, and
 - (iii) open-custody homes;
 - (n) probation and parole services;
 - (o) support to the Nunavut Criminal Code Review Board;
 - (p) community justice;
 - (q) guardianship and trusteeship;
 - (r) coroners;
