SOCIAL ASSISTANCE REGULATIONS, amendment

The Commissioner, on the recommendation of the Financial Management Board, under subsection 17(1) of the *Social Assistance Act*, R.S.N.W.T. 1988, c.S-10, as duplicated for Nunavut by section 29 of the *Nunavut Act*, orders as follows:

- 1. The *Social Assistance Regulations*, R.R.N.W.T. 1990, c.S-16, as duplicated for Nunavut by section 29 of the *Nunavut Act*, are amended by these regulations.**
- 2. (1) The following provisions are amended by striking out "the Territories" wherever it appears and substituting "Nunavut":**
 - (a) paragraph 1.1(2)(a);**
 - (b) paragraph 16(1)(e);**
 - (c) subsection 16(2);**
 - (d) subsection 26(1);**
 - (e) subsection 29(2);**
 - (f) subsection 42(4);**
 - (g) subsection 1(1) of Schedule A.**
- 3. Schedule A is amended by repealing the Food Allowance Table and substituting the Nunavut Food Allowance Table as set out in the schedule to these regulations.**
- 4. These regulations have retroactive effect to June 1, 2004.**
