SCHEDULE C OF THE LEGISLATIVE ASSEMBLY AND EXECUTIVE COUNCIL ACT AMENDING REGULATIONS, 2022

The Management and Services Board, under section 35 of the *Legislative Assembly and Executive Council Act* and every enabling power, makes the annexed *Schedule C of the Legislative Assembly and Executive Council Act Amending Regulations*, 2022.
